As I am sitting in London writing this, I must first thank God that neither I nor my wife was anywhere near the cowardly acts of terrorism perpetrated upon this great city two weeks ago on July 7. Today, July 21st, there has been a second attempt by a new group, although first indications are that the detonators went off prematurely, and the primary bombs failed to go off. Aside from the obvious relief at not being near the epicenter of the events, I began wondering if there was an amateur radio counterpart in the UK similar to our own RACES and ARES. Currently the primary amateur radio organization in the UK responsible for mobilizing in times of national emergency or disaster is known as RAYNET, and their website may be found at <http://www.raynet-uk.net/>.

During the recent tragic events on July 7, RAYNET groups in the greater London region were mobilized to standby in case they were needed by emergency crews. I'm not sure if the following was mentioned in the US media coverage of the bombing, but for several hours immediately following the blasts, all cell-phone communications networks were disabled intentionally by the UK police and national security services. This is an important item to note, since both in the Madrid bombings and the London bombings, the detonators were all set off from a cell-phone interface, which sets off the detonator merely with an incoming call. Amateur radio has a chance to play a very valuable role in this instance, even if the primary emergency services still have their own 2-way radio systems, which are independent of the cellular system. While not directly active as the events unfolded, RAYNET operators activated monitoring of designated emergency repeater frequencies during the cell-phone blackout. Amateur radio once again proves its worth in a time of emergency or crisis, this time by our fellow friends and ham radio colleagues in the UK.

Our ops were seasoned and aggressive and included N2CQ, AA2WN, AA2YO, W0MHK, and WA2NPD. Special thanks to Frank, KC2JIW, who helped immensely with erection of our antenna. The food was great this year, courtesy of WA2LET, Pinky, his XYL, and Bill, WA2ADB. Once again the generator operated near-flawlessly—thanks to Ray, WB2NB. We are looking forward to another effort next year.

Another GCARC first was recently reported. Bill, W0MHK, has just obtained his 10 Band DXCC! We are virtually certain Bill is the first member of GCARC to have ever achieved this distinction. Bill has over 100 hundred countries confirmed on the five major HF bands, the three WARC bands, 160 meters, and now 6 meters! The driving force is certainly the DXCC Challenge Award, where Bill is now closing in on the 2500 endorsement. Many congratulations to W0MHK for this really terrific achievement.

The recent FCC decision to drop all CW requirements for obtaining any Amateur License was met here with an enormous boo! It is a further and crucial example of the continuing “dumbing- down” of the Amateur Radio service. The next step, of course, will be the dissolving of the need for any license at all followed by the removal of all amateur allocated bands and frequencies, as the FCC will eventually realize that anybody can be an amateur radio operator! Oh well, it perhaps only seems that way, as there are probably more hams and potential hams that are glad that the nasty code requirement has finally been eliminated! Yet, the avid DXer knows the CW signal is still the most reliable means of communicating by today’s standards, and that CW will continue to be used for many years to come. Proposed Change to GCARC Constitution

To allow the Club Treasurer more flexibility and the ability to get the highest interest rate on the Club's money it is proposed that the first paragraph of Article II Section 5 of the GCARC Constitution be changed from the following:

Section 5. Treasurer. It shall be the duty of the Treasurer to be the recipient of and handle all monies of the CLUB. The Treasurer shall deposit same in the name of the CLUB in a bank located in the State of New Jersey. The Treasurer shall make all such payments for the CLUB as are provided by the Constitution, or such as shall be ordered by the Board of Directors. The Treasurer shall be a co-signer of all checks drawn upon the CLUB's accounts. The Treasurer shall issue a membership card to each member upon payment of his / her dues.

To the following:

Section 5. Treasurer. It shall be the duty of the Treasurer to be the recipient of and handle all monies of the CLUB. The Treasurer shall deposit same in the name of the CLUB in any FDIC insured account. The Treasurer shall make all such payments for the CLUB as are provided by the Constitution, or such as shall be ordered by the Board of Directors. The Treasurer shall be a co-signer of all checks drawn upon the CLUB's accounts. The Treasurer shall issue a membership card to each member upon payment of his / her dues.

The above proposal will be read and discussed at the next two General Meetings. Please attend and express your views on this proposal.
