CHAFTER II

EIGHT LITTLE, NINE LITTLE INDIANS

What was your answer to Mr. Madguy's question "Why should I spend a cent? You do it" (Pay for the service call, or install the filter.) You see, the TV set owner has, in his own mind, paid the last cent he expects to for the best T.V. he can buy. Now your telling him in effect that his been had-or so he thinks. And wait until your TVI complaint comes for a man who works for the set maker!

You have to assume (dangerous!) that Mr. Madwuy can still be logical about this, but here is a tried and trusty answer, "You can see from what we've been saying that the fault isn't with my transmitter, because the F.C.C. would clobber me in a minute if it were. So what you're asking me to do (pay for the service call) is not only to get you free a \$5.95 piece of equipment, but then to ray for putting it where your set maker should have in the first place. You see, the F.C.C. (the more you mention Fox Charlie Charlie the better!) says that the T.V. set makers know they should do this, but they take a calculated risk. Out of the thousands of sets they make, how many do you suppose might land, like yours did, near one of the 200,000 hams in the country? And a filter that might cost \$6.50 at the factory, installed, could raise the final cost of the set as much as \$25.00 or so by the time you figure in labor, mark-up for the Distributor, the Dealer and all the other people who get into the sale. Thats why your set needs this filter-just a matter of economics. And since you are going to get the filter free from the set maker, doesn't that prove he knows his sets are not as perfect as they might be? Tutting the filter in only takes a couple of minutes, and there won't be any parts charge, just a service call."

This leads to the other related question; "Well, why don't you install it?" If you want to take a chance, go ahead. But we don't recommend it. First of all, let anything go wrong with that TV set for the next six months, and who do you think will be blowed? Second, your neighborhood servicemen get touchy if they thank you're doing them out of a service call. Use the first fact to avoid the second. Don't get your fingers into the goodies. Leave it to the service man. And if your neighbor is adament about not spending a cent, tell him you'll see that he gots the filter as a courtesy, and that your responsibility ends there. Exit gracefully (if possible) and go on the air when you please. Eventually, he'll figure that he has the filter, and he might as well install it. As a matter of fact, if you show him how easy it is, Mr. Madguy just may do it to save the dollar or two he's so worried about; But don't you do it for anyone less closely related to you than your landlord or your wife's Cousin Jake.

Fifth Lurking Redskin - "You must be interferring: my TV looked (or sounded) awful last night!"

Just maybe you'll be lucky. Last night may have been the night your fried your final (these things do happen) Or maybe it was meeting night at the Club. Anyhow, quickly explain the log and what it must show by law. Frove you weren't anywhere near the mike or the key if you can - and half the battle is won. Then try this, "you know, there are many things besides ham stations that can interfere with a TV set, but hams usually get the blame. (you can't duck it if he or she has heard your call signal, bub.) I'd like to help you find out what is interferring with your set. What does the interference look (or sound) like?" Many times you can identify its source - like a fluorescent

light in the next room that drove our committee bats for a while, or cars going by. Look around for a second set in the house thats beating against the one complained about - or an FM radio. An try to describe "typical amateur interference patterns" so they can compare your description with what they have on their set. You may end up with a clean bill of health. (The ARRL publishes "Fatterns of Interference" - a chart you can get for the asking.)

Sixth Indian from the neighborhood warpath is "What d'ya mean its my set?"

"Well, Fr. Madguy, I have two sets at home. One is right in the same room with my transmitter and nothing interferes with it. I'd like to ask you to come over and see for yourself, (Better be sure your own T.V. is clean;) And I'd like to show you how a ham station is built and filtered so that it won't cause interference. (In the rare event that he does come over, contrast the shielded chassis of your rig with the open construction of T.V. sets. Compare co-ax with T.V. wire and lead-ins. Show him your low-pass filter and explain it in layman's language- of course you have an L P filter in the line, don't you?) If he won't come over - quite likely - talk him through what you would show him. Then add on as many cases as you can from the neighborhood of T.V. sets that aren't being interferred with while his is bothered. Makes him think. anyhow. Tell him you actually gave your phone number over the air and asked for interference reports (if you did - remember he hears your transmissions!) Tell him how you checked various neighbors and they said "No interference".... mentioning makes of sets and approximate age if you can, and another redskin bites the dust!

Thats it for this month. Educational, isn't it?? By the time you finish the last chapter you should be an expert, His

FROM ARRL HEADQUARTERS WEST HARTFORD COMM JUNE 9 1961 TO ALL RADIO ANAGEMES BT

ARML recommends and urges that all U.S. and Canadian amateurs voluntarily avoid any use of the 14355 to 14350 KC frequencies to permit better DX for all concerned. It should let amateurs in other countries work U.S. and each other with optimum success. The high end frequencies get more SSB use, those at the low end more AM use, and keeping the 15 KC at the top end for DX should strengthen this traditional pattern of use and benefit for all. There will be more in July QST on reserving the high end of 20 for SSB DX. All amateurs are requested to put this plan into effect immediately and it is suggested all amateurs outside W/VE land answer only calls from W/VEs working below 14335 KC AR

The attention of ameteurs interested in DX work is called to the addition of two countries to the ANGL Countries List. These additions are DANAO and DTU, Fortuguese territories situated on the west coast of India. Each of these will be considered as separate from each other and from the present listing of Goa. DXCC credit claims for either of these additions received before October 1, 1961, will be returned without credit. DXCC Notes in August QST will carry further data on the additions of DANAO and DTU to the countries list AR

ELIMINATION OF THE OZ4 IN MOBILE VIRRATOR SUPPLIES

There are many car radios and mobile B plus power supplies in use today using the OZ4. This full wave rectifier is a gas filled tube that does not require filament power. Two major complaints are frequent replacements required and 90 ma. maximum current rating which is often exceeded in some equipment. The voltage drop in the OZ4 is 24 volts. Low cost silicon diodes are now available that far surpass the advantages of the OZ4. One such diode is the 1N1696 which sells for \$1.20. This diode is good for over 250 ma. in a normal power supply circuit and 1/2 volt drop across it.

By buying two 1N1696's and a male cotal plug and wiring these parts as shown below you can replace the OZ4 without changing anything inside of your power supply. The total cost will be about (2.50 as compared to \$1.20 for each OZ4 which will have to be replaced many more times than that of silicon diodes.
