The generator was very tempermental, and ultimately quit early; WA2DYO and AI2B deserve a hearty "thanks" for keeping it operational as long as they did: The food was great (as usual) and that cold Lowenbrau sure helps you hear the tough ones (and maybe a few that weren't there at all!).

Basically, a good time and some intense hamming was had by all who participated. Unfortunately, there was one area of concern - the shortage of operators - three stations had two or less operators which is hard to understand given the club's size. This should be closely examined and changes made if our current procedures are shown to discourage club participation.

July shows two interesting oriented contest events:

July 9 - 10 IARU Radio Sport Contest

July 16-17 Seanet CW Contest

IARU is a World wide contest similiar to CQ's World - Wide DX Contests. Rules and logs will be available at the meeting.

The Seanet event aims to publicize the 12th Seanet Convention in November and is an excellent opportunity to catch some relativity scarce Pacific/Asian DX. Rules are in the May's magazines.

DX DOPE, (TNX to LIDXA es KE2M)

CHINA - BY1PK recently active on 14,010 KHz from 0100-0215 UTC. Just when you think the pileup has scared him away, he comes back with a string of calls he has plucked from the pileup after several minutes of listening. After sending his "list", he proceeds to work them one at a time. Be patient! QSL to Box 6106, Beijing, P.R. China.

IRAQ - YI1BGD on 14,205-215 KHz at 0500 UTC and again from 1730 UTC several days a week. QSL with 3 IRCs (don't send green stamps) to: Scientific Center, Box 5864, Baghdad.

KENYA - 5Z4CM, Charlotte, on 7004 or 7012 KHz weekends at 0400 UTC. She will QSL 80 meters on request. At 1100 UTC on Tuesdays and Thursdays, she favors 14,032 KHz cw or the YL SSB System on 14,332 KHz. Every day at 2200 UTC look for her around 21,350 KHz. QSL to Box 30514, Nairobi.

KNIGHTS OF MALTA - Keep an ear open for lAØKM on 10-80, cw, ssb and RTTY. They'll be on frequently through the end of May. QSL viz IØMGM.

MALPELO - In celebration of the 50th anniversary of amateur radio in Colombia, the LCRA plans to air HKØTU in October with at least four complete stations on 160-10 meters. Their previous operation was sheilded from W6/W7, so this time they will set up near the top of the mountain. HKØBKX will lead cw effort.

MOROCCO - CN8AR, Omar, near 3795 KHz daily from 0230 UTC. QSL to Box 229, Rabat. CN2AQ in the bottom 20 KHz of 80 meter cw most days from 0200. QSL CBA.

NAURU _ C21RK likes 14,240 KHz from 1230 UTC. QSL to P.O. Box 139, Rep. of Nauru, Central Pacific. C21BD is on every weekend near 14,220 KHz from 1130 UTC, and Tuesday and Thursday on Open House, 14,332 KHz from 1030 UTC. QSL to P.O. Box 225, Nauru.

PAKISTAN - AP2ZA daily on 21,290-295 KHz from 2100 UTC. QSL via W6NLG.

PETER ISLAND - THE DXAC has recommended the addition of this Antarctic island in the Bellingshausen Sea to the DXCC list. Visual sightings and photos taken last year noted a difficult but not impossible landing and siting situation here. At least one team is awaiting favorable ARRL action.

SVALBARD - JW5VVA is active daily from 2100-2400 UTC around 14,050 KHz or between 14,200-240 KHz. QSL via LA4YW.

SOUTH COOK - ZKICQ, Victor, says Top Band stations should stop ragchewing and listen for him trying to break in! He's on almost every day at 0700 and 0800 UTC, usually on 1812 KHz ssb. QSL to Box 618, Raratonga, Cook I., S. Pacific.

TRISTAN DA CUNHA - ZD9BX frequently on 21,310 KHz around 1900 UTC. QSL KA1DE.

CHAD - TT8AD on cw in the 050-075 segments of 10, 15 and 20 most days at random times between 1000 and 2000 UTC. QSL via HB9CLA or direct to BP 815, N'djamena, Chad. ***

EAST GREENWICH TOWER ORDINANCE STATUS

The issue is now dead unless someone wishes to fight the new ordinance. Despite the superhuman efforts of GCARC - with K2JF in the lead, the ordinance was passed. Admittedly, the Township Council tossed us a bone (an extra 10 feet), but 60 feet is hardly in compliance with the Federal regulation which binding. We believe (as does the Gloucester County Times) that if many more Township residents had appeared to help wage the battle, the outcome would have been much more favorable. Better luck next time! (Sure hope there isn't a next time somewhere else).

LEGAL HAPPENINGS, TNX to WESTLINK REPORT and K3WIL

ROUTINE LOGGING IN THE AMATEUR SERVICE has been eliminated. At their May 26th meeting, the Commissioners deleted the need for Radio Amateurs to keep logs for any communications. Included in this latest deregulation is the need for repeater station operators to keep audiotaped logs of telephone conversations to satisfy logging requirements. The Commission noted that "there is no longer an official need for records of routine station activity, "but added that field engineers and other FCC officials were delegated authority to require that specific individual stations be required to keep logs, if in their view, this is warranted. The Commission also noted that nothing in the new rules prevents Amateurs from keeping logs on a voluntary basis. (By FCC Report & Order 17529 on PR Docket 82-726.)

THE COMMISSION HAS STREAMLINED and modified some other Amateur rules (in Part 97) and deleted some it deemed unnecessary. This action made a number of editorial modifications for "clarification purposes" and amended others either to relieve "undue restrictions," or to codify them as a provision of the Communications Act. (FCC 83-237 by R & O May 26, 1983.) Included was deleting the necessity of RTTY and ATV stations to identify using the Morse Code. All changes will be incorporated into the next printing of Part 97.

THE DEPARTMENT OF DEFENSE and the National Telecommunications & Information Agency want more spectrum assigned to RACES operation in time of national emergency, and the FCC has issued PR Docket 83-524 aimed at addressing the issue. If approved, all Amateur frequencies would be automatically reassigned for exclusive, RACES-only use anytime the President invoked the Emergency War Powers Act. At other times, RACES would continue normal operations in the Amateur bands on a shared basis. Commentary cutoff is set for July 5th, 1983, with reply comments due July 20th, 1983.

THE FCC MAY HAVE MADE IT IMPOSSIBLE for C.B. operators to accede to one part of the controversial Burbank, Illinois anti-tower, anti-RFI ordinance. The city had demanded that Hams and C.B. operators register all such antennas using their assigned FCC callsigns. This is now impossible for all new users of the Citizens Radio Service. Last month, the FCC delicensed Class D C.B. and radio control, and are in the process of purging this information from its computer banks. The city of Burbank will be hard put to make C.B. operators register their antennas by their callsigns if they have no calls to register.

THE BURBANK, ILLINOIS TOWER CASE has moved a step closer to court after a magistrate recommended to the presiding judge that the city's "Motion to Dismiss" the Amateurs' suit be denied. (Story by Joe Schroeder, W9JUV.) In his recommendation, the judicial officer agreed that the Amateurs' argument that their constitutional right of free speech and their civil rights were both violated by Burbank's anti-tower ordinance. He was persuaded that this conclusion raises a Federal issue and therefore does belong in Federal District Court. A "Status Call" has been set by the judge for June 21st when he is expected to adopt the magistrate's recommendation. A trial date should be set soon afterward.
