EAST GREENWICH TOWER ORDINANCE UPDATE

Following a working discussion with the Township hams and several members of the GCARC, The Township Fathers have revised their proposed Tower Ordinance to eliminate reference to RFI and have raised the height restriction from 50 to 60 feet. The final reading of the revised ordinance will occur at the regular township meeting in June. Although an improvement over the original version, this new ordinance falls far short of what Hams believe should be satisfactory and, of course, continues to violate federal statues which are overriding at any event. Nevertheless, unless further action is taken and is heeded, this ordinance will become law in June.

The United States has arrangements to permit United States amateur radio stations to exchange third party communications with amateur radio stations in these countries:

The United States also has an agreement with the International Telecommunication Union (ITU) permitting third party communications with its station 4U1ITU in Geneva, Switzerland.

International amateur radio communications are limited by the International Radio Regulations, which state in part that they shall be made in plain language and shall be limited to messages of a technical nature relating to tests and to remarks of a personal character for which, by reason of their unimportance, recourse to the public telecommunications service is not justified. Business messages are prohibited. At the end of an exchange of international third party communications, each amateur radio station must transmit the call sign of the foreign station in addition to its own call sign.

### SPRATLEY VENTURE

TWO RADIO AMATEURS WERE KILLED as a result of a Vietnamese attack on an unarmed yacht. The boat was carrying four operators plus a crew of two for a DXpedition to the isolated Spratley Island chain in the South China Sea. Killed during the 15 minute attack on the 51 foot catamaran "Sidhartha" on April 10th was Diethelm Mueller, DJ4EI, who was hit by an artillery round and fell overboard when the yacht caught fire. The second victim was "Gero" Band, DJ3NG, who succumbed to exposure and dehydration while adrift for 8 days in a tiny dingy with the four remaining members of the party. The survivors, all listed as suffering from exposure and gunshot wounds, are: DXpedition leader, Baldur Dronica, DJ6SI; Norbert Willand, DF6FK; and the skipper, Peter Marx and his wife Jenny. The 4 were picked up by the Panamanian-registered freighter "Linden" and were taken to Hong Kong and hospitalized. According to a West German Foreign Ministry official who talked with one of the survivors by radiotelephone, the gunners were identified as Vietnamese on the Island of Amboina Bay. Vietnam has a garrison on that island, which is part of the hotly disputed Spratley group. (See WLR-391 for earlier details.) Tnx W6RCL, NBC Network News.

### ARRL BOARD OPPOSES NO CODE !

In a decisive, unanimous decision last month, the Board rejected all FCC proposals regarding creation of any form of No Code License and has instructed the League attorney to prepare a formal reply to that effect. Generally, this was a most welcome decision regarding the ham fraternity feelings as most ham polls have been running nearly 100 to 1 against any no code concept. In addition, the FCC mail has reportedly been running



50 to 1 against their proposal. Hence, the League has acted precisely as the membership has indicated and this is to their credit for, in this case, we believe the majority is also right. As reported in April, GCARC voted 51 to 1 against. Amen!

### INTENTIONAL COMPUTER INTERFERENCE COSTS AMATEUR LICENSE

The Advanced Class Amateur License of Henry C. Armstrong III (WA6CGI) of Sylmar, California, has been revoked by the FCC Review Board for the balance of its term for intentionally transmitting computer generated interference during December of 1980. Armstrong also was found to have illegally engaged in one-way communications and broadcasting, both a violation of the rules. FCC Judge Fitzpatrick had previously found that Armstrong deliberately interfered with operation of the Southern California DX Club Repeater and attempted to mislead the Commission as to his true purpose in making the prohibited transmissions. He concluded that revocation of Armstrong's amateur station license and the suspension of his operator license was in order. Armstrong appealed the decision to the FCC Review Board.

In a decision released March 11, the FCC Review Board generally upheld the decision of Judge Fitzpatrick and affirmed the revocation. The FCC Review Board said that Armstrong's transmissions are not in dispute. "...Engineers heard Armstrong continuously transmitting a computer voice synthesized audio signal that included his call sign, a statement that the station was under computer control, the frequency, and the amount of time the station had been on the air." The voice synthesized transmissions did not address anyone in particular. In defending his actions, Armstrong argued that he was conducting permissible experimental testing related to the development of a computer program with which a human voice could communicate by radio, telephone or other electronic means. Armstrong has an Electrical Engineering degree and training in computer design and hardware/software development. He acknowledged staying on the air for seven or eight hours at a time.

Representatives of the Southern California DX Club offered evidence casting doubt on Armstrong's explanation. The DX Club had even offered to buy Armstrong new crystals that would operate on a frequency not close to the repeater in order to eliminate the problem and said that they thought his transmissions were the implementation of a threat (denied by Armstrong) to drive the repeater off the air. Armstrong also said that the FCC judge did not allow him to enter evidence into the record. In denying Armstrong's allegation, the FCC Review Board said the transcript makes no reference of his wanting to enter additional evidence supporting his innocence. "Furthermore", the Review Board stated, "Armstrong failed to monitor the output frequency before or during his transmissions to determine if he was causing interference, despite having been warned previously that his earlier transmissions had caused serious interference to other Amateur operations." The revocation/suspension order becomes effective April 20th

unless further appealed to the full Commission.

China. BY1PK in Beijing and BY8AA in Chengdu are still very active on 2Ø and 15 meter CW. BY7RA in Guangzhou is scheduled to begin operation within a few months. QSL all stations direct to CRSA QSL Bureau, P.O. ZOX 61Ø6, Beijing. There is still no SSB operation, but plans are being made for SSB from BY1PK later this year. Any station who worked VE7BC on his March/April visit to BY1PK can OBT a QSL directly from Tom, VE7BC.

Antarctica. 4K1QAV is a new Soviet station from Antarctica. QSL to UA1QAV.

Singapore. 9V1VB shows regularly on 15 meter CW with good signals to both Europe and North America. Check especially around 1ØØØ to 14ØØZ on 21Ø25 KHZ.

Liberia. A81LC A82LC A85LC A87LC A88LC and A89LC will be operated through the rest of the year by members of the Liberia Radio Amateur Association. QSL to SM4CWY AR

Zone 2. VO2CW will be leaving VO2 land at the end of the summer.

Senegal. 6W8DS can be found on 21295 KHZ at 2Ø3ØZ. QSL to WA4VDE.

Saipan. Len, KHØAC, is active on weekends on 142Ø5 KHZ at 1ØØØZ.

Gabon. TR8JJD operates around 14245 KHZ at Ø1ØØZ.

Malta. Look for 9H1EU at 2030Z on 2129Ø KHZ.

Cook Islands/Niue. ZK1CG and ZK2DR are hearing North American stations well around Ø8ØØZ on 1812 KHZ but are having trouble being heard.

Brunei. VS5HG is active around 142Ø6 KHZ at 1925Z.

Amsterdam Island. Mike, FB8ZP, has been regularly appearing from Ø2ØØ to Ø3ØØZ on 142Ø5 KHZ. QSL to F6KNO.

Mauritius. 3B8CF continues active on 4Ø and 8Ø meter CW just before his sunrise. QSL Direct.

Oman. A4XJV, Salim, licensed since last September, is now very active on 2Ø and 15 meter SSB. QSL direct to 1983 Callbook Address.

San Marino. Many stations have become suddenly very active with the new prefix assignment T7. Heard this week were T77V and T77C on 15 meter CW. For QSL routes, use the address of the M1 station with the corresponding suffix.
