## FAR NEWS RELEASE

THE FOUNDATION FOR AMATEUR RADIO, INC., a non-profit organization with Head-quarters in Washington, D.C. plans to award fifteen (15) scholarships for the academic year 1984-85. The Foundation composed of fifty local area amateur radio clubs, fully funds two of these scholarships from the proceeds of its annual Hamfest. It administers without cost to the donors, three scholarships for the Quarter Century Wireless Association, two for the Dade (FL) Radio Club and one each for the Radio Club of America, the Richard G. Chichester Memorial, the Young Ladies' Radio League, the Edmund B. Redington Memorial, the Amateur Radio News Service, the Columbia (MD) Anateur Radio Association, the Baltimore (MD) Amateur Radio Club and the Lewis G. Wilkinson Memorial.

Licensed Radio Amateurs may compete for one or more of these awards if they plan to pursue a full-time course of studies beyond high school and are enrolled or have been accepted for enrollment in an accredited university, college or technical school. Most of the scholarships require the applicant to hold at least an FCC General Class license or equivalent. The scholarship awards range from \$350 to \$900 with preference given in some cases to residents of specified geographical areas or the pursuit of certain study programs.

# LEGAL HAPPENINGS, TNX to "WESTLINK" es K3WIL

AN EX - LOS ANGELES HAM has been ordered to spend the next 18 months behind prison bars. On Monday, January 15th, US District Court Judge Manual Real sentenced <u>Richard Burton</u>, the former <u>WB6JAC</u>, on 4 misdemeanor counts of operating a transmitter without a license.

Under Judge Real's order, Burton will spend <u>a year</u> in Federal Prison, followed by 6 <u>months</u> in what is described as a "jail type of facility". After his release from custody, Burton will be placed on 5 years probation, during which he "shall not be found in any place in which any kind of broadcast is made by radio or otherwise."

Each count in Burton's conviction brought with it a maximum 1 year prison sentence but normally, in the case of multiple convictions, such prison time is to be served concurrently. In this case Judge Real handed down 2 consecutive sentences, each covering 2 counts of Burton's conviction. Burton has been ordered to surrender himself to the US Attorney General at noon Monday, January 23rd, to begin serving his sentence.

Burton's problems with the government date back to 1980, when, after having received numerous letters of complaint, the FCC's Long Beach, California, Field Operations Bureau began an investigation of his on air activities. He was monitored by field engineers violating a number of Amateur Rules, including those involving intentional interference and violations of part 97.119. This latter section prohibits radio amateurs from transmitting language that is considered obscene, indecent or profane.

As a result of this investigation, the Private Radio Bureau issued an order revoking his station license and his operator's permit. Burton requested a hearing before an Administrative Law Judge, but that request was subsequently denied because he failed to respond within the time limits proscribed by the Rules.

The revocation order was affirmed, but Burton chose to ignore it. For the next several months, he was observed, monitored and documented as continuing to operate without a license, primarily from his apartment in Reseda, a suburb of Los Angeles.

In May, 1982, a 7 count Federal Grand Jury Indictment was handed down against Burton. He was charged with 4 counts of operating an unlicensed radio transmitter and 3 counts of transmitting obscene, indecent or profane language. He was found guilty on 6 of the 7 counts, and on June 28th, 1982, Judge Real sentenced him to 1 year in prison on the 4 misdemeanor counts of unlicensed operation and 2 years on each of 2 felony counts.

## IT'S OKAY TO VIDEOTAPE COMMERICAL T.V.

Voting 5 to 4, the US Supreme Court decided that Sony Corporation had not violated copyright laws through the sale of VCRs and blank tape for them.

The suit had been brought against Sony as a test case by various organizations in the entertainment industry who feel that home taping is theft of their products. With the ruling against them, it is now expected that some in the industry will petition Congress for a rewrite

of the copyright laws. With 1984 being an election year it is doubtful that Congress will take any action that could be construed as an increased burden on their constituents.

The license of Paul O. Overlock, N6BHC, has been revoked by an FCC Administrative Law Judge for violation of the Citizens Band Rules.

ALJ Joseph Stirmer took the action to deny Overlock's application for a General Class operator's license and to suspend his Technician Class license after he found out that Overlock had willfully violated the CB rules in 1979.

The Law Judge found, specifically, that he had operated on an unauthorized frequency, used nontype accepted equipment, communicated over a distance greater than 250 km and had failed to properly identify his station.

Judge Stirmer noted that since the incident, Overlook had displayed good conduct in operating his amateur station, and recommended that Overlock be permitted to file a new license application in 90 days.

The decision was issued January 10th, and becomes effective in 50 days unless an appeal is filed within 30 days. (FCC Report 17827)

A CB INVASION OF 10 METERS seems to be taking place in the Southwestern US. In what appears to be a well coordinated move to expand unlicensed operation onto 10 meters, illegal operators began setting up shop from 28.0-28.5 MHz the weekend of January 15th. Over 3 dozen QSOs were copied Saturday and Sunday including 2 nets! The main topic of conversation appears to be the FCC decision to kill No Code. Most, though not all, operate lower sideband, and many operators claim to be from locations outside the US, thus outside FCC jurisdiction. This is odd because why would so many non-US citizens be so interested in a codeless US amateur license?

# FCC CLARIFIES NOVICE EXAM RULES

On Jan. 20th, 1984, the FCC eliminated the proviso that the Examiner could not be the employer of the applicant (and vice-versa), but, retained that the examiner must not be blood related to the applicant. This also means related through or by marriage. Hence, your mother-in-law, for example, cannot proctor your novice exam (perish the thought, ed. comment). The employer employee relationship was particularly though on Americans overseas who work for the Federal Government.

#### INTERNAL FCC PROCEDURES DELAY VEC PROGRAM

"Internal adminstrative delays" within the FCC are still holding up final designation of the first batch of Volunteer Examination Coordinators. Once these delays are overcome, it is expected that 3 major amateur radio organizations will be named to kick off the program of volunteer testing for all classes of licenses.

The 3 to be named are the Anchorage ARC of Alaska for the KL7 call district, the Metroplex ARC of New York for the 2nd district and a MARS group headquartered in Puerto Rico to oversee the process in the KP/Caribbean region.

As far as ARRL involvement in the program goes, a high ranking source at the FCC says that the stumbling block between the League and the Commission remains ARRL insistence that it be named the "National Volunteer Examination Coordinator."

As previosly reported, the FCC says that no one will be named to such a position due to the enabling legislation which allowed a VEC program to exist.

The League denies that they are making such a demand and say that negotiations with the FCC are continuing.

FCC MONITORING STATIONS are still on the lookout for Rules violators. Regardless of the financial cutbacks they have suffered, the Commission continues to routinely monitor the amateur bands. In the Pacific, monitoring stations are believed to be listening especially closely to the maritime mobile nets, checking for proper use of callsigns and insuring that no violations occur in the handling of traffic.
