AT&T Gets Portable Phone Red-Light

After 12 years of procrastination, the FCC gave the go-ahead for revolutionary (except to hams) mobile phone service. Barring legal challenges, AT&T will apply within the year to provide the new "cellular" radio communications service in several major metropolitan areas. Cellular technology provides expanded and near interference-free mobile phone service by dividing a city into tiny districts or "cells", each served by its own transmitter. Computers switch a caller from one frequency to another as the caller moves from cell to cell. Hence, the same frequency can be used simultaneously by many callers as long as they're in separate cells. Looks like "Dick Tracy" has finally come alive!

Legislative Information

K2JF

An amateur station power limit of 2000 watts PEP input to the final amplifier when using SSB (A3) is proposed in the "Plain language" rules (AR Rule 31 - present rule 97.67). Also proposed plain language rule 97.310 provides that FCC would measure power output with a radio frequency power meter in your antenna transmission line and multiply that measurement by 1.25 to determine the peak envelope power (PEP) input (1600 watts output).

As a flag is to a flagpole, so an antenna is to a tower. An Essex county New Jersey amateur has won a court battle over his antenna and tower in which one of the points in the judge's favorable ruling was the flag comparison. The case was a 65 foot tower with an antenna on top. One of the rulings the judge made was that the antenna is to a tower as a flag is to a flagpole, i.e., not in any sense a structural part. "A flag can be replaced without affecting the flag pole and the antenna can be changed without affecting the tower structure." This declared in Superior Court of New Jersey.

Copies of Assembly Bill No. Lal will be available at the club meeting with a letter to your Assemblyman for a "FOR" vote. This bill allows amateurs to have radios in their cars that will be capable of tuning in the Police or Fire frequencies.

Study of future of Low Power TV: The FCC's recent action allowing low power TV stations in various localities has created a tremendous amount of interest. Because of the intense interest, the Commission has issued interim guidelines for use by its staff in granting applications. (Maybe we won't have Channel 2 in our area.)

"IMPORTANT" Recommended Changes to the Constitution of the Gloucester County Amateur Radio Club, Inc. will have its FIRST reading at the Club meeting. Copies of the present constitution and copies of the recommended changes will be available. Here is your chance to make a change. Speak now or forever hold your peace.

Ask your State Representative (Florio) for a copy of the Federal Register /Vol. 45, No. 246/Friday, December 19, 1980/ Proposed Rules. (This is the so called "Plain Language revision").

Due to the cut-back in funds, all FCC Public-Participation Workshops have been canceled. BUT WE (the GCARC Hamfest) will have a representative from the Philadelphia FCC to conduct FCC exams at our Hamfest - Technician to Advanced (Who do we know? Ed.)

The ARRL will raise their dues to \$25.00 a year effective July 1, 1981.

New 610 Forms for Renewal of your Amateur licenses are now available from the Club's sex-a-tary. Ask Roz for them.

Don't forget to get your copy of HR 2203 The Dannemeyer Bill for volunteer assistance to FCC by Amateurs. A SASE to WAOTEY will get you a copy of HR2203.

Docket 78-369 An "Option Paper" is to be released during the first quarter detailing a "statistical summary of comments" on the Extent of Radio Frequency Interference to electronic equipment and the need for government rules to lessen such RF1.

Spread Spectrum has been OK'ed for experimental use on some of the amateurs bands. AMRAD has been given temporary authorization on March 6, by the FCC. Frequencies that may be used are: For "Frequency Hopping", 3.675-3.775; 7.050-7.150; 14.1-14.2; 28.1-29.3 all in MHz: "Direct Sequence" 420-431, 438-442. Bandwidths will vary from 16 KHz to 1.0 MHz. Service Frequencies "Where pretest CW or SSB will be 3.725, 7100, 14.150 + 10 KHz. I am a member of AMRAD.

The British are now "officially" allowed to work the 27 MHz CB band; however, the 930 MHz band is being considered for final CB by the House of Commons.

PR 79-130 900 MHz Personal Radio Service due out for discussion by the FCC April 1981.

DX Items of Interest (Tnx to KE2M)

Benin. Karl, K4YT, operating from TYAll was active daily on 40 and 80 meter SSB. Karl is to leave Benin for Germany today. GHIS, ON5NT, will operate TYAll on CW from 18 April through 2 May.

Central African Republic. TL8RC is reportedly active on 40 meter SSB and CW around 0100Z.

South Shetland Islands. HFØPOL is the call of a Polish base on King George Island in the South Shetland Island group. Bogdan favors 20 and 40 meter CW around the lower band edge.

Space Shuttle. There is a special Johnson Space Center Commemorative QSL card for those who worked W5RRR during the space shuttle event this past week. QSL via the Callbook address.

Solomon Islands. Ron, ZLIAMO, is due to begin operating from the Solomon Islands on 19 April for a two week period. The call sign to be used is not known at this time.

Iran. EP2KG and EP2KK were heard on 10 meter SSB last week giving out P.O. Box numbers in Tehran as their QSL routes. Watch 28530 KHz for these calls.

Lesotho. 7P8AC is newly active and has been reported testing some new equipment and antennas on 10 meter sideband.

North/South conditions on 160 meters have been superb with the following stations reported regularly, LU9EIE, AU1DZ, PY1ZAE and LU8DQ.

Kuwait. 9K2AH has been reported on 10 and 15 meter CW around 1200 to 1500Z. QSL JA8BW.

Saint Partir. Profit /FS is being operated by F30A and FC9VN, concentrating on CW, 80 to 14 others.

Mineman/Palmyra. The group has apparently been told not to land at Palmyra and some straight to Kingman Reef for a landing at 1600Z Thursday 16 April. Keep an ear open for much KH5K activity.

ARRL BULLETINS OF NOTE

The FCC'S Field Operations Bureau reported March 5 that it has fined Denald L. Rhoads, of San Francisco, \$750 for "deliberately interfering with the operation of an amateur radio two-meter repeater station located on nearby Grizzly Peak." The Commission charged that "Rhoads, whose station was unlicensed, falsely identified it by using a call sign belonging to a licensed amateur radio operator, transmitted obscene, indecent, and profane language, as well as music and party records, which jammed the repeater and prevented its use by authorized amateur radio operators."

(Ed. Note: Great! Now how about KB6TG, W6RTN, et al.??)

The FCC March 4 released an "order" dismissing a petition from Robert W. Stankus, of Easton, Conn., which had asked that the Commission prohibit amplitude modulation for voice communications in the amateur radio service.

The United States and the Gambia, Prefix C5, have agreed to permit the exchange of third party messages, but not phone patches, by their amateurs effective April 15, 1981. The messages must be of a technical or personal nature not important enough to justify transmission by the public telecommunications network. An exception permits the handling of messages related to the safety of life or property when an emergency has disrupted the public system. Please add the Gambia to the list of third party traffic agreements appearing on page 92 of April 1981 QST.

Senator Barry Goldwater, K7UGA, has introduced a bill, S 929, which would amend the communications act with respect to amateur radio and matters affecting private land mobile and fixed stations. The bill was cosponsored by Senators Packwood and Cannon, Chairman and Ranking Minority Member respectively of the Commerce Committee and by Communications Subcommittee members Schmidt, Pressler, Stevens, Hollings and Inouye. The amateur portions of the bill were suggested by ARRL. Similarly, we understand that the other items in the bill in general reflect the desires of land mobile and fixed station users in the private sector. Additional information will be available from ARRL HQ. A self-addressed envelope would be appreciated.

River Vale, New Jersey, amateurs will celebrate the town's 75th anniversary from April 20 through June 20. A special commemorative QSL will be available for contacts during this period. On June 20, three stations will be active, operating 15 KHz up from the edge of each subband. QSL to N2BUO.
