### ANTENNA RAISING ACCIDENT

This ham is sitting at his desk answering a letter from his insurance company:

"I am writing in response to your request for additional information for block three of the accident report form. I put "poor planning" as the cause of the accident, but you said that I should explain more fully and I trust the following details will be sufficient.

I am an Amateur Radio Operator and on the day of the accident I was working alone on the top section of my new 80 foot tower. When I had completed my work, I discovered that I had, over the course of several trips up the tower, brought up about 300 pounds of tools and spare hardware. Rather than carry the un-needed tools and material down by hand, I decided to lower the items down in a small barrel by using a pulley, which fortunately, was attached to the gin-pole at the top of the tower.

Securing the rope at ground level, I went to the top of the tower and loaded the tools and materials into the barrel. Then, I went to the ground and untied the rope, holding it tightly to insure slow decent of 300 pounds of tools. You will note in block number eleven of the accident reporting form that I weigh only 155 pounds.

Due to my surprise of being jerked off the ground so suddenly, I lost presence of mind and forgot to let go of the rope. Needless to say, I proceeded at a rather rapid rate of speed up the side of the tower. In the vicinity of the 40 foot level, I met the barrel coming down. This explains my fractured skull and broken collarbone. Slowed only slightly, I continued my rapid ascent, not stopping until the fingers of my right hand were two knuckles deep into the pulley.

Fortunately, by this time, I had regained my presence of mind and was able to hold onto the rope in spite of my pain. At approximately the same time, however, the barrel of tools hit the ground and the bottom fell out of the barrel. Devoid of the weight of the tools, the barrell now weighed approximately 20 pounds. I refer you again to my weight in block number eleven. As you might imagine, I began a rapid descent down the side of the tower. In the vicinity of the 40 foot level, I met the barrel coming up. This accounts for the two fractured ankles and the lacerations of my legs and lower body.

The encounter with the barrel slowed me enough to lessen my injuries when I fell onto the pile of tools and fortunately only three vertebrae were cracked. I am sorry to report that, however, as I lay there on the tools in pain, unable to stand and watching the empty barrel 80 feet above me..... I again lost my presence of mind and I let go of the rope.

# 20M PHONE BAND EXPANSION

Expansion of the 20 meter phone band becomes effective May 22, 1983 at 0001 UTC. The new phone bands will be as follows. 14150 to 14175 KHz, EXTRA. 14175 to 14225 KHz, ADVANCED and EXTRA. 14225 to 14350 KHz, GENERAL, ADVANCED and EXTRA. THIS IS NOT EFFECTIVE UNTIL MAY 22, 1983 at 0001 UTC.

Also, note that a NPRM has been issued by the FCC regarding possible expansion of the phone portion of 80 Meters. More news about this later on.

### DX DOPE, TNX to SNEDXA es KE2M

DESECHEO ISLAND. The FCC has changed the prefix of Desecheo Island from KP4 to KP5.

TURKEY. ARRL HQ has received word from the Turkish Amateur Radio Club that the Government has passed legislation officially recognizing Amateur Radio once again. The process will take about six months, at which time Amateur Radio will be legal by Government standards.

BRUNEI. VS5MS can be found on 1421Ø KHz at 143ØZ.

GABON. TR8JD operates around 21300 KHz at 2130Z. QSLS are being handled by F6AJA.

ST. MARTIN. K6GXO/PJ7 is active on 2129 $\emptyset$  KHz at 21 $\emptyset$  $\emptyset$ Z. QSLS to to his home QTH.

WEST MALAYSIA. Look for 9M2SQ on Sunday mornings at 1Ø3ØZ around 1421Ø KHz.

AFRICA/SOUTH ATLANTIC. An informal group meets on 21335 KHz between 1700 and 2000Z. ZD9, ZD8, ZD7, TJ, TQ, TU and 7Q7 stations are available regularly.

#### LEGISLATIVE NOWS

(TNX to WESTLINK es K3WIL)

- A. <u>AMATEURS WISHING TO FILE COMMENTS ON "NO-CODE"</u> with the FCC will have an additional 60 days in which to do so. The Commission has granted an ARRL request to extend the commentary period on PR Docket 83-28 to permit the League and other interested parties the time necessary to fully digest the proposal and file their opinions. The new due date for comments is June 28th, with reply comments accepted for the following 30 days. The "No Code" issue will probably be the major topic discussed at the upcoming ARRL Directors' meeting; many knowlegeable Amateurs expect a drastic change in the League's vehement anti-No Code stand.
- B. A "10 YEAR AMATEUR LICENSE" was discussed at the recent FCC meeting, but no decision was made. Instead, it was decided that the method to be used in handling the matter should be by a Notice of Proposed Rule Making which will be released shortly. The Commissioners want the Amateur community to weigh all the pros and cons of such a license term, including the possible problem of Amateurs forgetting to renew due to the length of the long term. There will be no way for the Commission to pre-notify Radio Amateurs that their licenses may be expiring since that would take the FCC over budget. Also to be answered is whether such a license term should be made retroactive to all current licensees, only granted to new licensees, or granted to current license holders on renewal. No docket number has been released as we go to press.
- C. <u>COMMERCIAL RADIOTELEPHONE LICENSES</u> may soon be a thing of the past. The FCC has adopted, and will shortly release, a Notice of Proposed Rule Making aimed at deleting the requirement that individuals hold a General Radiotel-ephone license for most applications not involving international communications. According to an FCC spokesman, there has been a significant drop in the number of applicants for this license because of some of the regulatory changes that were made in 1982 which affected the need for the license in both the commercial broadcasting and the General Radio Services. No NPRM number was available at presstime.

#### EAST GREENWICH TWR ORDINANCE

Following a work session presentation at the April 7th Township meeting, the Committee agreed to put the proposed Ordinance back in Committee for possible modification of the 50' height restriction clause. The jury is still out, however. Nevertheless, the efforts of N2SI, K2JF, WB2ZND - together with the Township hams have, thus far, been successful.
