Unless I'm mistaken, our annual participation in the American Cancer Society Bike-A-Thon from Philadelphia to Atlantic City is the largest Amateur undertaking in several ways, such as: Number of Amateurs involved - about 60, Distance covered - 62 miles, Number of persons involved relying on our activity - 2,500 in '83 - 3,000 projected for '84. Feels good to be #1, but have you taken the time lately to think about your emergency preparedness? We participate in the Bike-A-Thon to assist in their emergencies, However, months of planning is spent to ensure that the Bike-A-Thon including the Amateur Communications, flow smoothly and effeciently.

Lets not overlook one of the fundamentals of Amateur Radio - COMMUN-ICATIONS in time of an emergency.

ARMED FORCES DAY, MAY 19th

(TNX to ARRL Letter & K2QGH)

This year marks the 25th Anniversary of communications tests between Hams and Military operators (X-band modes) as part of the Armed forces Day activities. The X-band tests will include CW, SSB, RTTY, and SSTV. The receiving test will feature 2 messages from the Secretary of Defense, one in CW (25 wpm) followed by the other in RTTY (60 wpm) starting at 1300 UTC on the 19th until 0245 on the 20th. Military stations will transmit on selected military frequencies and, at that time, the military operator will announce the specific Ham frequency being monitored. If interested, drop an SASE to "The ARRL Letter" (at the League) requesting the table of frequencies to be used. Then submit a transcript of your monitored message to the appropriate address for the branch of the Military worked to receive your certificate.

WHY JOIN ARRL?

As one of several Assistants to our Atlantic Division Director it seems natural at this time to write a little something about why you in GCARC should be an ARRL member. Apparently the enthusiasm for ARRL is dragging just a bit! Well, thats not uncommon. Many hams around our CLUB feel \$25 a year for QST and the other advantages of ARRL is too much and so they dropped their ARRL membership. Others remember that at some time in the past, some ARRL policy upset them; so they refuse to join. Still others simply ask, "WHAT HAS ARRL DONE FOR ME?"

Well . . . those of you who belong to the 1st and 3rd groups should read on; those who bear old grudges can skip along to the next article in this issue of Crosstalk because I'm sure I'll never change your mind (and I'm not sure I'd care to).

Without going into a history lesson, let me say that since it's founding early in this century, ARRL has been in the forefront of the fight to expand and preserve the Amateur Radio Service. ARRL has the ear of those groups in Washington which decide what privileges you are given. Remember your "right" to operate a ham radio is not a "right" . . . it is a privilege, given to you by your government and the governments of the world. Just as easily as they gave you that privilege, they can take it away from you; that is why ARRL was so heavily involved in the preparation for the 1979 World Administrative Radio Conference (WARC). ARRL spent a lot of member money supporting FCC and other regulatory bodies to make sure ham radio didn't get the "shaft" at the World Conference! And that effort paid off. Amateur Radio was among the most prepared services at the Conference. like ARRL from all over the world prepared their government negotiators. Instead of losing bands as some predicted (like good ole The result? never say die), we gained three bands for our ultimate use!

More recently, FCC almost gave it to the two-meter operators of the country with their "no-code" proposal. Where do you suppose the majority of those no-coders would have settled down to operate? Twenty meters? Hardly so! If you think the repeaters of America are crowded now, imagine what they could have been if no-code had been implemented.

It was the organized resistance of the ARRL which played an important role in killing no-code once and for all (HOPEFULLY!). While the equipment manufacturers and the various ham radio publishers and the like were touting no-code as the saviour of their business, ARRL members took a stand and helped defeat it. ARRL didn't do it alone; plenty of non-ARRL members did their part, too, but it is the ARRL to whom FCC looks and listens intently.

Why do you suppose that is? Because ARRL is <u>NOT</u> the building in Newington . . . it is <u>NOT</u> the WlAW station, and it is definitely NOT QST: FCC understands that <u>ARRL IS THE 140,000-PLUS AMATEURS IN THE U.S.A.</u>

AND CANADA WHO ARE SPEAKING. FCC KNOWS this; why don't you?

At this time, I could go on and on about ARRL and how it serves you. I have served as an Assistant to the current Director as well as the three who served prior to him. I haven't even mentioned the limited legal aid available if you end up in a zoning or antenna height battle. I haven't mentioned the WIAW bulletin and code practice transmissions (free to anyone with a receiver).

The publishing part of ARRL is the business end of the organization. The purpose of that business is to serve its members.

ARRL is an organization of amateurs. ARRL responds to its members and tries to serve them, keeping in mind that its members are a diverse lot . . . from contesters and DX'ers to OSCAR satellite users and two-meter FM'ers.

What has ARRL done for you lately? Plenty! All you have to do is keep your MIND, your EYES and EARS OPEN, and you'll see ample evidence that your \$25 per year dues are well worth it.

There has been some objection to the one page set aside for the YL/XYL in that it reminds one of the Ladies Home Journal. Have you read this one page lately! In there you will find many active YL/XYL who are outstanding in their radio activities. Percentage wise the number of YL/XYL is small but those who are active are worth being mentioned somewhere in print.

And, if you think the battles are all over, remember that some countries are now pushing to hold a WARC $9\emptyset$, and again . . . ham radio frequencies are on their big list !!

Are the equipment manufacturers, Wayne Green or Dick Bash going to spend their money and time protecting amateur radio and supporting FCC? Sure they will!

ARRL and its members will do it AS THEY HAVE SINCE FORMING THIS ORGANIZATION. Non-members will continue to benefit from the people who send their dues in every year; life is cruel! But you could JOIN ARRL and add YOUR VOICE to that of your friends. Send your membership to the treasurer today --- by paying through the CLUB the CLUB also makes \$2 per membership. Don't forget to give our treasurer your card you receive from the League when you pay the dues.

Think about it and the next time someone asks what ARRL did for you lately, tell them. And while you are at it, JOIN. Our GCARC treasury can keep \$2 of your \$25 and with our 150-plus membership thats a neat amount of money for GCARC to receive annually. An added \$300 to any club treasury is nothing to frown upon. As for myself I have been a Life

Member of ARRL for several years and do not pay any more dues - perhaps you, too want to become a Life Member. Think it over.

 $\underline{\text{YI}}$ Iraq has established 8 amateur radio districts, YII thru YI8. It's felt that we may see more operation from Iraq in the near future.

160M The power limit has been lifted on the top 100 KHz of the band. US amateurs may now use full legal power over the entire 200KHz of 160M.

LEGISLATIVE NEWS

TNX to K3WIL, K2JF, and "Westlink"

- 1. The first VEC testing in NJ will be on May 12th at the Bergen County Community College. The testing will include Novice, Technican, and General. Call (201) 447-7107 for details. K2JF announces that GCARC (Hamfest) will also have VEC testing hopefully up through Extra Class. More on this later on.
- 2. ARRL Bulletin Nr. 30, April 13, 1984. To all Radio Amateur BT The ARRL petition for rulemaking filed on March 28 which requested that the new internationally allocated bands at 24.89 to 24.99 MHz and 902 to 928 MHz be opened up for US amateur has been assigned RM 4784. With regard to the 24 MHz Band, the League requests that the lower 40 KHz be reserved for Al and Fl emissions with the upper 60 KHz available for Al, A3, A4, A5, F3, F4 and F5 emissions. Comments are due at FCC on or before May 1, reply comments are due on or before May 29. See happenings in May QST for details AR.
- 3. Amateur examinations at FCC offices presently scheduled for November, 1984, will be the last, generally speaking. FCC expects that the Volunteer Examiner Program will be fully operational by then. The only tests conducted by FCC after that will be on a case-by-case basis at the convenience of the Commission.
