## **AMATEUR ARRESTED**

From the W5YI REPORT: "Eric Dobrowansk, KA6YCK, of Cranford, NJ was recently arrested and indicted by a grand jury for having ham gear in his car capable of operating on police channels adjacent to the two meter ham band. What makes this case interesting is that Eric had gone down to the police station to offer his services as a ham operator to help find the source of police radio jamming." His trial is scheduled for the end of September or early October, John Norton N2IOB who is familiar with radio law is his lawyer. New Jersey is one of only a handful of states in the country where it is ILLEGAL to carry a scanner capable of receiving public service frequencies in your automobile. What makes the law unusual and dangerous is the fact that you have violated the law merely by having the radio in your possession. You can even be convicted under this law if you are stopped in the middle of a conversation on your local two meter amateur repeater! If the radio is in your car and it is capable of receiving a public service frequency then you are in violation of the law. The New Jersey Law makes mere possession a crime! I have a letter from my Chief of police that authorizes me to carry my two meter radio with me because of Emerg. Mgt work. If you want more information see the Sept 15, 1991 W5YI REPORT.
