#### FEC TO CRACK DOWN ON BBer's

It has been reliably reported that the Commission is about to
lower the boom on hamming by CBer's
A docket that has been before the
commission for some months appearantly has been adopted after some
2500 interested parties filed their
objections to same.

In an informational letter addressed to all FCC district offices, from Washington, it was state ed that the docket will become fully effective on 1 November 64. The letter goes on further to state that "Licensees are specifically prohibited from engaging in radio communication as a hobby or diversion; that is operating the radio station as an activity in and of itself."

It has been found that the utility of CB is being impaired because of the persistent hamming

even though the hobby type of operation is distinctly not the purpose of this service. The commission warns that if there is continued misuse of operating privliges it will consider again weather this service should be continued.

Among other things the new rules prohibit "communications to other stations relating to technicial performance, signal strength, stability, etc."

The commission had two roads open; to open CB to hamming or to crack down and make the band usuable for legitimate short range communication. Appearantly the latter is to be enforced.

# WHAT YOU MAY ENTER

- 1. Any piece of electronic gear used as an accessory or for the direct transmission or reception of radio signals
- 2. Any operating proceedure applicabe to a ham station
- 3. Any modification of a commercial piece of gear (modification must be original and must be your own idea)

Note: Exact copies of equipment from Handbooks, etc. are not permitted, schematics may be used. Under operating proceedure any article of not less than 1000 words may be submitted.
