CELLULAR SILENCE

As expected, Senate Bill 1431, a proposed law that would make illegal the manufacture, sale or possession of receivers capable of receiving 800 MHz cellular telephone calls, passed the California Senate on June 26. The measure was opposed by Senator Walter Stiern of Bakersfield, who had discussed it with a number of amateurs in his district.

The bill now goes to the Assembly, where it is expected to be assigned to the Public Safety Committee, headed by Larry Stirling of San Diego. If it makes it out of committee intact, we expect it to be fought by Assemblyman Richard Katz of the San Fernando Valley.

Joe Merdler, N6AHU, still plans to meet with Herschel Rosenthal, the sponsor of this legislation, if he can get one the scanner manufactuerers to provide a receiver for a demonstration to Senator Rosenthal.

Merdler says that he is getting very little help in his attempt to block passage of this damaging legislation — even from the manufacturers. Only S.C.A.N., funded by Uniden-Bearcat, has shown any real interest in fighting this bill. Regency and J.I.L. manufacture receivers for this new band.

N6AHU told <u>Westlink</u> that the real problem is that no one seems to be watching the government. SB-1431 was introduced way back in March, and no opposition was registered during public hearings, so the matter was reported out of committee as "non - controversial" legislation.

Merdler, who characterizes Rosenthal as "misguided," reports that the real forces behind this proposal were AT&T, Pac-Tel and ACLU. He says that our best hope of defeating the bill is by showing members of the Assembly how foolish California will look when the measure is taken to federal court.

BROADCASTERS LIKE HAMS

The May, 1985 issue of Television Broadcast Communications Magazine carried some high praise for the ability of radio amateurs to solve engineering problems in the broadcast industry. In his "Tech -Talk" article, writer Don Wilkinson dealt with remote news and production crews and their abilities to handle unforeseen emergencies. that the experience of hams in successfully dealing with transmitter and antenna problems "shows up repeatedly." Detailed was one instance where the feedhorn for an electronic news gathering (ENG) microwave transmitter was lost, with only minutes to a live remote broadcast. Steve Flyte (K7SF), who was the remote engineer, successfully fashioned a replacement from a length of coaxial cable! The live shot made it on the air, and with almost normal signal strength. Wilkinson, Chief Engineer of KTAU-TV in Portland, Oregon, concluded by writing: "When I find a job applicant is 'turned on' about electronics enough to make it his hobby as well as his profession, I always take a second look. A ham radio callsign indicates to me that this individual has an extra depth of experience that can save the day in a pinch."

CRIMINAL COMPLAINTS FILED AGAINST JAMMERS

The FCC announced on July 3, 1985, that criminal complaints had been filed against three individuals accused of making illegal Amateur Radio transmissions. These complaints resulted in the arrest of Glenn L. Barrick of Detroit, Richard Szabo of Farmington Hills and Robert J. King of Redford Township. Pending the filing of formal charges against the individuals involved, the criminal complaints have now been dismissed by the U.S. Attorney for the Eastern Division of Michigan.

Dismissal of the criminal complaints now allows the cases to be processed in a more routine manner. Upon complete review of the case information, the results may be presented to a federal grand jury to seek indictments for violation of Federal law. Conviction could result in a possible maximum sentence of one year in prison and a \$10,000 fine for each offense.

The FCC's Detroit District Office conducted the investigation and located numerous complaints about deliberate interference being caused to Amateur Radio communications.

...AND MORE FCC ENFORCEMENT ACTIONS RESULT IN FINES FOR CB OPERATORS

Fines totalling \$900 were levied June 28, 1985, on Joseph Roberson of Philadelphia, Pennsylvania, for operation of his CB radio at a power level in excess of 4 watts. After numerous complaints from residents of a North Philadelphia neighborhood concerning interference to their television reception, an FCC engineer determined that the transmitter used by Roberson was overpowered. Attempts by the engineer to inspect the equipment were, and continue to be, refused.

Also in Philadephia, Harry O. Jackson was fined \$750 on May 10,1985, for unlawfully interfering with television reception over a period of half a year. His CB radio was calculated by the FCC to be transmitting with a power of 47 watts.

COMPUTER USER FINED FOR TELEVISION INTERFERENCE

On May 9, 1985, the U.S. Attorney for the Eastern District of Pennsylvania announced that a total of \$3000 in fines was sought in a suit was filed against Comp-Art, Inc., for unlawfully interfering with television reception in a South Philadelphia neighborhood over a period of 18 months.

An FCC engineer determined that a computer used by Comp-Art was causing the interference. Under FCC regulations the computer used by Comp-Art may not be used if it causes interference with television reception. Fines were levied on Comp-Art for failing to correct the problem and shield the computer to eliminate the interference.

VCR RFI WORRIES INDUSTRY

Serious RFI problems with VCRs -- RF pickup by the playback head because of poor shielding, plastic cases, etc., in the 500-700 kHz and 3.5 MHz ranges -- has industry worried. The concern is that prices of VCRs are expected to drop to as low as \$159 by Christmas ... making it likely that neighbors on all sides of a ham can afford a VCR.

TNX to "the ARRL Letter and K2JF"

If you remember in the "Hamfest" edition of <u>Crosstalk</u>, we said that the names of the "BIG GUNS & LITTLE PISTOLS" of the GCARC would be given to you for your information and help in starting DXing. The BIG GUNS (300 countries or more) are W2SUA "Shorty" N2SS, Tony, WA2VEE Bill, NJ2C Bud, K2OWE Jim; the Little Pistols (Under 300 countries are: WA2NPD Doug, K2HPV Herb, KD2CR Len, KE2M Tom, and K2JF John. Now if you contact any one of these fellows they will be glad to give you a helping hand in "shooting DX. "These fellows all have DXCC.

OK let us continue on a little bit in reference to getting started. If you are primarily a CW man the task is really not much to it. tioned before the 40 and 80 meter bands are wide open after the Sun sets, The Twenty meter band gets pretty good early in the AM (7:30 to about 8:30) for the JA's and Pacific areas; so come on and see how many JA's prefixes you can work; and you don't need a beam to do it. Yeah, I grant you it helps, but it is not necessary. OK on 40 the best suggestion I can give you is to look at a ½ wave horizontal or a ¼ wave (I use a Sultronics trapped antenna SLOPER that works 40, 80 and 160. I do very little 160 but it works very well on 40 and 80 and it does not take up much room.) Don't forget the G5RV antenna. baby works well on 80 thru 20. Rember outside of your Transmitting and Receiving equipment there are TWO very important devices you should have: (1) A LOW PASS FILTER and (2) a Transmatch for your antenna. PASS filter is a MUST; whereby the Tuner is a good idea to match your antenna to the various frequencies you are going to use. If you are going to run QRO you will need a power meter also, so you can monitor your Power Output not to exceed ;500 watts PEP.

Ok, now I have my equipment squared away, is there anything I can get to help me that will tell me what DX is around? The answer is YES. The Long Island DX Bulletin is one of the most important publications you can get. It cost you \$24.00 a year but it is an invaluable aid in shooting DX. A copy will be on the table for you to see (Please don't take - it some other fellow may want to see it before the night is over). There are some local DX listening frequencies. 144.400 is the SJRA DX call out, 144.930 is another call out frequency, and 147.270 is the

Frankford RC clubs call out frequency. Listen to these when some DX is around and here you can find out (1) What DX is hot; (2) Where it can be found (Band and Freq); and is it a Net or List operation or is the DX shooting "BUCKSHOT."

Hey wait a minute-what is this Net, List, and Buckshot type of operation? That is the next topic for another <u>CROSSTALK</u> article if you want it. Let me know if there is any interest in these type of articles. ARRL FILES NOVICE PETITION WITH FCC The ARRL Executive Committee May 18th proposal for enhanced Novice privileges was filed as a <u>Petition for Rule</u> Making with the FCC on June 6th. The ARRL Novice petition provides for: (1) 10 meter voice privileges (except double sideband AM) between 28.3-28.5 MHz and CW/digital 28.1 - 28.3 MHz. Full amateur (1000 watt PEP output) power to be authorized with Technicians automatically gaining enhanced Novice privileges. (2) Full amateur privileges in the 220 - 225 MHz band with 25 watt PEP output limit. (3) All voice, CW and data privileges between 1246 and 1260 MHz. Five watt PEP output limitation.
